**Waverly City Board of Education
Regular Meeting**

January 10, 2018

The Waverly City Board of Education met for the organizational meeting on Wednesday, January 10, 2018 at 5:30 p.m. in the High School Study Hall. Ms. Zaler called the roll. 010-18 APPROVAL OF MINUTES
